Subject: Guidelines for implementation of revised IS 4948: 2020- Welded Steel Wire Fabric for General Use

- 1. IS 4948: 2002 has been revised as IS 4948: 2020 and has been published. The last date for implementation of the revised Standard is 02 Aug 2021 after which the old Standard shall stand withdrawn.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within **a week of issuance of these guidelines**.
- 3. In this revision, reference standards have been updated and editorial correction has been done at Cl. 6.1. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.
- 4. Consequent upon issuance of the revised Standard, existing Product Manual has been revised as Doc: PM/IS 4948/2/June 2021. In this revision of product manual, year of the Standard has been updated.
- 5. The guidelines for implementation of the amendment is given below:

A. <u>LICENSEES</u>:

(i) All Licensees shall implement the revised Standard by 02 Aug 2021 and send confirmation to the BO. Any difficulty in implementation shall be brought to the notice of CMD III at the earliest but in any case at least 30 days before the last date of implementation. BOs shall ensure that no Licences are under operation as per old Standard after 02 Aug 2021. The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications as well as applications which are recorded henceforth may be processed as per the revised Standard.
- 6. The above guidelines come into force with immediate effect.
