Sub.: Launch of the On-line Module for Jeweler Registration & Renewal and AHC Recognition and Renewal

In accordance with the Hallmarking Scheme of Bureau of Indian Standards, registration to sell precious metal articles of gold and silver jewellery/artefacts is granted to a jeweller and recognition is granted to A&H centre for hallmarking the jewellery.

2. As per present norms, jewellers and A&H centres are submitting applications for registration and recognition through application form in hard copy .

3. In view of the mandatory hallmarking the number of jewellers and AHCs applying for BIS certificate will increase manifold and to deal with increasing number of applications, an online system for issuing BIS certificate has been developed and will be launched on 21.08.2020.

4. The porting of the existing details of registered jeweler and recognized AHC is under process. For complete porting 7 days' time is required after the last grant of registration/renewal in the CMMS.

5. In view of above and as advised by Competent Authority in the meeting taken today, it is requested that BOs may accept hard copy of new applications for registration & renewal of Jeweller upto 11.08.2020 only. The registration and renewal of the jeweller applications received till 11.08.2020, shall be granted by 11.08.2020, 20.00 hrs. Similarly ROs may accept new applications for recognition & renewal of AHC upto 11.08.2020 only.

6. No new registration/renewal shall be granted to jewelers and entered in CMMS after 11.08.2020, 20.00 hrs. Similarly no new applications for recognition & renewal of AHC may be received in hard copy after 11.08.2020.

7. The grant of Jeweler Registration & Renewal and AHC Recognition and Renewal shall be done online after 21.08.2020.
