Subject:- Temporary measures for relaxation of provisions of BIS (Hallmarking) Regulations, 2018 in view of extraordinary situation in the country

- 1) In view of the extraordinary situation in the country due to Covid-2019 pandemic the relaxation have been provided by BIS to the jewellers, A&H centre and refinery/mint in applying for renewal of BIS Registration, Recognition and Licence respectively. The relaxations were issued vide HMD circular number HMD-14/44, dated 22.04.2020 and are as follows:
 - i) For all the jewellers for which renewal of certificate of registration is due during the period of lockdown and upto 30 days after:
 - a) Provision of expiry of certificate as per sub-regulation (1) of Regulation 6, Chapter I of BIS (Hallmarking) Regulations 2018, is kept in abeyance till 30 days after the lifting of lockdown.
 - b) Provision of deferment of certificate of registration up to three 3 months as per sub-regulation (2) b) of Regulation 6, Chapter I of BIS (Hallmarking) Regulations 2018, is kept in abeyance till 30 days after the lifting of lockdown.
 - ii) For all the A&H Centre for which renewal of recognition is due during the period of lockdown and upto 30 days after:
 - a. Provision of deferment of recognition as per sub-regulation (4) of Regulation 11, Chapter II of BIS (Hallmarking) Regulations 2018, is kept in abeyance till 30 days after the lifting of lockdown.
 - b. Provision of submission of late fee with renewal application within 90 days i.e provisions of sub-regulation (5) of Regulation 11, Chapter II of BIS (Hallmarking) Regulations 2018, is kept in abeyance till 30 days after the lifting of lockdown.
 - c. Provision of deferment of recognition beyond 90 days by keeping sub-regulation (6) of Regulation 11, Chapter II of BIS (Hallmarking) Regulations 2018 is kept in abeyance till 30 days after the lifting of lockdown.
 - d. Provision of suspension due to non-payment of marking fee to the Bureau within stipulated period., as per sub regulation (3, viii) of Regulation 12, Chapter II of BIS (Hallmarking) Regulations 2018, is kept in abeyance till 30 days after the lifting of lockdown.
 - iii. For all the licensees of refinery/mint for which renewal of recognition is due during the period of lockdown and upto 30 days after:
 - a) Provision of deferment of recognition as per sub-regulation (5) of Regulation 17, Chapter III of BIS (Hallmarking) Regulations 2018 is kept in abeyance till 30 days after the lifting of lockdown.

- b) Provision of submission of late fee with renewal application within 90 days i.e provisions of sub-regulation 6 of Regulation 17, Chapter III of BIS (Hallmarking) Regulations 2018 is kept in abeyance till 30 days after the lifting of lockdown.
 - c) Provision of deferment of recognition beyond 90 days by keeping sub-regulation (7) of Regulation 17, Chapter III of BIS (Hallmarking) Regulations 2018 is kept in abeyance till 30 days after the lifting of lockdown.
- 2) **In view of present situation the applicability of relaxations is extended up to 30 September 2020 instead of 30 days after lifting of lockdown.**
- 3) This issues with the approval of the competent authority.
