3. Their initial pay in the post of Scientist 'B' will be fixed on receipt of their option in the required proforma which may be sent to the undersigned within one month. Option once exercised will be final.

All officers shall assume duty at the new place of posting immediately on 02 April 2018 (F/N). The admissible joining time may be availed by them in due course. They will be entitled to TA as admissible under rules.

6. From the date of their promotion, they shall be on probation for a period of two years which may be extended by the Appointing Authority as permitted under the Rules and Regulations. During probation, Director General may arrange to give such training and responsibilities as deemed necessary and prescribe departmental examination or examinations to be passed for successful completion of probation. During the period of probation, they are liable to be reverted back to the post held by the officer before promotion to the post of Scientist 'B' without assigning any reason.

7. They will be required to serve anywhere in India.

8. As regards other terms and conditions of service, they will be governed by the BIS Scientific Cadre Rules and other Rules & Regulations in force from time to time.

9. They should send a report regarding their assuming the charge of Scientist-B at new place of posting.
