Evidence was collected by entering the premises discreetly and took photographs. Also, a case, comprising of 24 bottles of 500ml bearing fake ISI mark was bought from a nearby provision store. The sample was sealed and coded as CNBO/65501/20240621/CP/1.

Where, as a result of any search made under sub-section (1), any goods or article, process, system or service has been found in relation to which contravention of section 11 or sub-sections (6) or (8) of section 14 or section 15 or section 17 has taken place, the certification officer may seize such goods or article and other material and documents which, in his/her opinion will be useful for, or relevant to any proceeding under this Act:

Provided that where it is not practicable to seize any such goods or article or material or document, the certification officer may serve on the owner an order that he/she shall not remove, part with, or otherwise deal with, the goods or article or material or document except with the previous permission of the certification officer.

The provision of the Code of Criminal Procedure, 1973 (2 of 1974), relating to searches and seizures shall, so far as may be, apply to every search or seizure made under this section.
