**Subject: Extension of date of implementation of amendment no 3 to IS 15658 : 2006
'Precast concrete blocks for paving'**

1. Guidelines for implementation of amendment no 3 to IS 15658 : 2006 was circulated vide CMD-III circular ref: CMD-III/16:15658 dated 24/09/2018 with last date for implementation as 28 February 2019 which was further extended upto 30 September 2019.
2. Representations have been received from various BOs for extension of implementation date, change in frequency of Tensile Splitting Strength (clause 6.2.7) and Flexural strength/ Breaking load (clause 6.2.8) as well as permitting sub-contracting for these tests. The matter was reviewed and the frequency of these tests have been revised to once in six months and also subcontracting of these tests has been permitted. Product Manual Doc: PM/IS 15658/2/November 2019 with revised SIT is issued for implementation.
3. Last date for Implementation of amendment no 3 to IS 15658 : 2006 is extended upto 31 March 2020.
4. All BOs are requested to inform the revised date as well as Product Manual to all Licensees/Applicants immediately. BOs may also ensure implementation of amendment no 3 to IS 15658 : 2006 by 31 March 2020, as no further extension may be possible. Other terms and conditions of CMD-III's circular dated 24/09/2019 remain the same.
