### **Subject: Guidelines for implementation of Revised IS 10350:2020 Powder Hair Dyes**

1. IS 10350:1999 has been revised as IS 10350:2020 and has been published. The last date for implementation of the revised Standard is **12 June 2020** after which the old Standard shall stand withdrawn.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard **within a week of issuance of these guidelines**.
3. The significant changes in the revised Standard as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

<b>Clause</b>	<b>Requirement</b>
3	A new type of powder hair dye, namely, Type 3 (others) covering entire range of fashion hair colours like black, brown, red, blonde, purple etc. have been included.
5.3	Marking clause has been revised to harmonize it with Rule 148 of Drugs and Cosmetics Rules, 1945. Caution/warning related to PPD content in the product have been aligned with IS 4707 (Part 2). 12 local languages for primary patch test instructions have been included.
4.5, table 1, sl. No. (ii) & (iii) (Annex B)	Method for determination of arylamine content has been modified.
4.5, table 1, sl.no. (ii) & (iii) (Annex C)	A new method for determination of PPD content in salt form has been incorporated.
4.5, table 1, sl.no. (ii) & (iii) (Annex D)	An alternate method for identification and estimation of dye ingredients by HPLC method has been incorporated.
4.5, table 1, sl.no. (iii) (Annex E)	A new method for identification and estimation of picramic acid by HPLC method has been incorporated.
2	Cross referred standards have been updated.

4. Consequent upon the issuance of the revised Standard, existing STI has been revised as Scheme of Inspection and Testing (SIT) - **Doc: SIT/ 10350/ 1 March 2020** which is being circulated separately.
5. The guidelines for implementation of the revised Standard is given below:

#### **A. LICENSEES:**

- (i) All Licensees shall implement the revised Standard by **12 June 2020**. BOs shall ensure that no Licences are under operation as per the old Standard after **12 June 2020**. **The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-2 within two weeks of the last date of concurrent running.**
- (ii) Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports or Test Certificates, as applicable. Verification of implementation of the revised Standard, wherever required, may be done during the next visit.
- (iii) If the Licensee fails to complete all actions by **12 June 2020** it shall be dealt with as per the prevailing guidelines.

**B. APPLICATIONS FOR GRANT OF LICENCE:**

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall from such Applicants also be obtained that in new test requirements, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto **11 June 2020** and for such cases Applicant shall give a declaration that they will implement the revised Standard by **12 June 2020**.
- (iii) Beyond **12 June 2020** no Licence shall be granted as per the old Standard.

**C. CHANGE IN SCOPE OF LICENCE:**

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only upto the date of implementation of the revised Standard or upto **12 June 2020** whichever is earlier.

6. The above guidelines come into force with immediate effect.
