This has reference to the subject mentioned above.

The guidelines for certification of Split AC as per IS 1391 (Part 2) have been modified based on the inputs received from stakeholders and considering the various scenario in manufacturing of air conditioner. The modified guidelines have been issued vide circular No. CMD-III/16: IS 1391 (Part 2) dated 19 August 2020. Consequent upon the issuance of these guidelines, the Product Manual has also been revised to address various situations.

The approved revised Product Manual (Doc No. PM/ IS 1391 (Part 2)/ 4/ Aug 2020) for “**Room Air Conditioners - Split Air Conditioners**” as per **IS 1391 (Part 2): 2018** has been hosted on the BIS website under “Conformity Assessment → Product Certification → Product Specific Guidelines → Product Manual”.

In this revision of the Product Manual, necessary changes have been made in Grouping Guidelines, Sample Size, List of Test Equipment, SIT, Possible Tests in a Day and Scope of Licence for catering to the specific situations of grant and operation of licence.
