Subject: Implementation of latest version of cross referred standards in Packaged Drinking Water (other than Packaged Natural Mineral Water) as per IS 14543:2016

During a recent preventive vigilance audit, it was observed that the BOs are not aware about the revision of standard, IS 15185:2002 as IS 15185:2016, test method for E-coli referred in IS 14543:2016, Specification for Packaged Drinking Water. This has been viewed seriously by the Competent Authority. IS 14543:2016 refers to IS 15185:2002 for testing of E-coli. IS 15185 was revised in 2016 as IS 15185:2016/ISO 9308-1:2014 'Water Quality – Detection and enumeration of Escherichia coli and coliform bacteria – Membrane filtration method for water with low bacterial background flora'. The test given in the revised IS 15185:2016 is different from the one given in IS 15185:2002.

Therefore, all ROs/BOs are advised to check the implementation of latest test method standard IS 15185:2016 for E-coli by the licensees/applicants. Since, there is modification in the medium etc. of the above mentioned test, all licensees/applicants be informed and verification may be done during the next surveillance visit.
