### **Subject: Guidelines for Implementation of amendment no. 2 to IS 15298 (Part 4):2017 - Personal Protective Equipment Part 4 Occupational Footwear (Second Revision)**

1. Amendment No. 2 to IS 15298 (Part 4):2017 has been published. The last date for implementation of the amendment is **18 March 2020**.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment.
3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause	Changes
B-1.1	Language in which information is to be supplied with each pair of boots has been changed from Hindi and English to English and any other language
B-1.1 (e)	Requirement for supplying information of Time period for obsolescence has been removed
B-2 d)	Requirement for marking Shelf life on each boot has been removed

4. Consequent upon issuance of the amendment, there is no change in the existing STI.
5. The guidelines for implementation of the amendment is given below:

#### **A. Licensees:**

- (i) All Licensees shall implement the amendment by **18 March 2020**. BOs shall ensure that no Licences are under operation as per IS 15298 (Part 4):2017 without the amendment after **18 March 2020**.

#### **B. Applications for Grant of Licence:**

- (i) Applications which are recorded henceforth may be processed with or without consideration of the amendment. Processing of Applications without consideration of the amendment shall be permitted only upto 17 March 2020 and for such cases Applicant shall give a declaration that they will implement the amendment by **18 March 2020**.
- (ii) Beyond **18 March 2020** no Licence shall be granted without consideration of the amendment.

**C. Change in Scope of Licence:**

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
  - (ii) However, processing of such applications for change in scope of licence without consideration of the amendment shall be permitted only upto the date of implementation of the amendment by the licensee or upto **18 March 2020** whichever is earlier.
6. The above guidelines come into force with immediate effect.
