Subject: Guidelines for implementation of amendment no. 2 to IS 16186:2014 (Textiles - Lightweight Jute Sacking Bags for packing 50 kg food grains -specification)

- 1. Amendment No. 2 to IS 16186:2014 has been published. The last date for implementation of the amendment is **24 August 2019**.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.
- 3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause	Requirement
4.1	Definition of type B bags has been modified to include bags woven on modern shuttle less loom
7.2	BIS Certification Marking clause has been updated as per BIS Act, 2016.

- 4. There are no changes in the existing SIT.
- 5. The guidelines for implementation of the amendment is given below:

A. LICENSEES:

- (i) All Licensees shall implement the amendment immediately. BOs shall ensure that no Licences are under operation as per IS 16186:2014 without the amendment after 24 Aug 2019.
- (ii) Verification of implementation of the amendment, wherever required, may be done during the next visit.
- (iii) If the Licensee fails to complete all actions it shall be dealt with as per the prevailing guidelines.

B. <u>APPLICATIONS FOR GRANT OF LICENCE</u>:

(i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of the amendment. However, if the Applicant is desirous of considering the amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants

- that if the sample fails while considering the provisions of the amendment, Licence will not be granted as per the old version.
- (ii) Applications which are recorded henceforth may be processed only with or without consideration of the amendment. Processing of Applications without consideration of the amendment shall be permitted only upto **23 Aug 2019** and for such cases Applicant shall give a declaration that they will implement the amendment by **24 Aug 2019**.
- (iii) Beyond **24 Aug 2019** no Licence shall be granted without consideration of the amendment.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence without consideration of the amendment shall be permitted only upto the date of implementation of the amendment by the licensee or upto **24 Aug 2019** whichever is earlier.
- 6. The above guidelines come into force with immediate effect.

AMENDMENT NO. 2 JULY 2019 TO

IS 16186 : 2014 TEXTILES — LIGHT WEIGHT JUTE SACKING BAGS FOR PACKING 50 KG FOODGRAINS — SPECIFICATION

(*Page* 1, *clause* **4.1**, *Type B*) — Substitute the following for the existing:

'Type B — Double warp, single west woven on conventional shuttle loom or modern shuttle less loom.'

(*Page 3, clauses* **7.2** *and* **7.2.1**) — Substitute the following for the existing clauses:

'7.2 BIS Certification Marking

The bales and jute bags may also be marked with the Standard Mark.

7.2.1 The product(s) conforming to the requirements of this standard may be certified as per the conformity assessment schemes under the provisions of the *Bureau of Indian Standards Act*, 2016 and the Rules and Regulations framed thereunder, and the products may be marked with the standard mark.'
