This has reference to the certification of electrical kitchen machines as per IS 302-2-14: 2009.

It is seen that a number of Applications have been received at several Branch Offices for grant of Licence. IS 302-2-14 covers the safety requirements of various electrical machines such as centrifugal juicers, food mixers, food processors, shredders, hand-held blenders etc. Accordingly some manufacturing units have applied for the Licence of more than one kitchen machine.

In this regard, queries have been received from BOs on whether to process all of these products under a single application or multiple ones for each machine.

The matter has been examined and it has been decided to process all products covered under IS 302-2-14: 2009 in a single Application and hence grant a single Licence. Each electric kitchen machine shall be treated as a separate variety under the same Licence.

In this regard, it is also observed that many Applicants have applied for Safety of Food mixers and centrifugal juicers as per IS 302-2-14: 2009. Such applicants may be apprised of the fact that Domestic Electric Food Mixers (Liquidizers and Grinders) and Centrifugal Juicers as per IS 4250 are being brought under mandatory certification w.e.f. 01 May 2019 and obtaining a Licence for these products as per IS 302-2-14 does not absolve them from obtaining a Licence as per IS 4250.

This issues with the approval of Competent Authority.
