AMENDMENT NO. 2 APRIL 2005

IS 4588: 1986 SPECIFICATION FOR RUBBER, RAW, NATURAL

300 Cross

(Third Revision)

(Amendment No. 1, clause 5.1.1) - Substitute the following for the existing:

'5.1.1 An identification strip of polyethylene bearing the colour as indicated in the following colour code shall be wrapped on each bale:

Grade ISNR ISNR ISNR ISNR ISNR ISNR ISNR
3CV 3L 5 10 20 ,50

Colour Light White Green Brown Red Yellow
Code Green

The colour code of each grade of ISNR to be implemented either by wrapping a colour strip of polyethylene on each bale, or by printing the poly cover of the bale in that ink.

(Page 4, clause 5.1) - Substitute the following for the existing:

'5.1 The block rubber shall be packed in 25 or 50 kg bales or as agreed to between the purchaser and the supplier. The material shall be wrapped in low density polyethylene sheets and shall be further wrapped as agreed to between the purchaser and the supplier (see IS 5598: 1986).

The block rubber shall be further packed in pallets or crates, if required, as agreed to between the purchaser and the supplier as follows:

Material of pallet/crate: Wood, steel or any other material as agreed to

Net mass of rubber: IMT/1.2MT/1.26MT or as agreed to between the purchaser and the supplier.'

(Page 4, clause 6.1) - Substitute the following for the existing:

'6.1 For delivery in individual bales each bale of raw natural rubber shall be marked indelibly with grade of rubber; net mass of bale, name of producer/estate, or trade-mark, if any, batch number and month and year of production.'

Amend No. 1 to IS 4588: 1986

(Page 4, clause 6.1) — Insert the following subclause after 6.1:

'6.1.1 For bales in pallets or crates, each pallet or crate shall be marked indelibly with grade of rubber, net mass of pallet/crate, name of producer or estate, or trade-mark, if any. Marking of Batch No., month/year of production, net mass of bale etc, be either marked on individual bales, or on crates.'
