Subject: Guidelines for implementation of Revised IS 4654:2019 - Paraffin Wax

1. IS 4654:1993 has been revised as IS 4654:2019 and has been published. The last date for implementation of the revised Standard is **27 Feb 2020** after which the old Standard shall stand withdrawn.

- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- 3. The significant changes in the revised Standard as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

Clause	Requirement
4.2	Test methods for melting point and determination of oil content are updated
Annex A	Automatic melting point apparatus and temperature measuring devices alternate to mercury thermometer are included

- 4. Consequent upon the issuance of the revised Standard, existing STI has been revised as a Scheme of Inspection and Testing (SIT) Doc: SIT/4654/1 Dec 2019 which is being circulated separately.
- 5. The guidelines for implementation of the revised Standard is given below:

A. <u>LICENSEES</u>:

- (i) All Licensees shall implement the revised Standard by **27 Feb 2020**. BOs shall ensure that no Licences are under operation as per the old Standard after **27 Feb 2020**.
- (ii) Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports or Test Certificates, as applicable. Verification of implementation of the revised Standard, wherever required, may be done during the next visit which may normally be completed within six months of the last date of concurrent running.
- (iii) If the Licensee fails to complete all actions by **27 Feb 2020** it shall be dealt with as per the prevailing guidelines.

B. <u>APPLICATIONS FOR GRANT OF LICENCE</u>:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall from such Applicants also be obtained that in new test requirements, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto

26 Feb 2020 and for such cases Applicant shall give a declaration that they will implement the revised Standard by 27 Feb 2020.

(iii) Beyond 27 Feb 2020 no Licence shall be granted as per the old Standard.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only upto the date of implementation of the revised Standard or upto **27 Feb 2020** whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
