Subject: Grant of Licence /Inclusion of additional varieties in the licence as per IS 4923:1997 *Hollow steel sections for structural use*.

- 1. Guidelines for implementation of IS 4923:2017 was circulated vide CMD-2 circular ref:CMD-2/16:4923 dated 31/10/2017 & 07/11/2017 with last date for implementation as 25 February 2018.
- 2. Subsequently, the last date of implementation has been extended for six months i.e. upto 25 August 2018 and same has been communicated vide circular ref:CMD-2/16:4923 dated 06/03/2018.
- 3. In view of the amendment envisaged for implementation of IS 4923:2017, provisions for processing of inclusion in the existing licence and processing of applications for grant of licence as per IS 4923:1997 is amended as given below:
 - i) Inclusion of additional varieties in the existing licence as per IS 4923:1997 shall be permitted upto the date of changeover of the licence to the revised IS 4923:2017 or upto last date of implementation i.e. 25/08/2018 whichever is earlier.
 - ii) Processing of application for grant of licence as per IS 4923:1997 shall be permitted upto last date of implementation i.e 25/08/2018. However the applicant shall submit an under taking that all actions for changeover to revised IS 4923:2017 shall be completed before last date of implementation i.e.25/08/2018.
- 4. The above guidelines shall come into force with immediate effect.
- 5. This is issued with the approval of DDG (certification).
