**Subject: Guidelines for implementation of revised standard for Toe Caps for Protection of Feet – Part 1: Metallic Toe Caps according to IS 5852 (Part 1):2019**

1. IS 5852:2004 has been revised as IS 5852 (Part 1):2019 and has been published. The last date for implementation of the revised Standard is **23 Oct 2019** after which the old Standard shall stand withdrawn.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard **within a week of issuance of these guidelines.**
3. The significant changes in the revised Standard as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

Clause	Change
1	In IS 5852 : 2004, two types of metallic toecaps were prescribed, one for footwear having leather soles and one for footwear having rubber/moulded soles. In this revised standard, this classification has been removed and the requirements of toecaps have been specified for safety and protective footwear. This standard has been aligned with ISO/DIS 22568-1.
4.5	Requirement of corrosion resistance has been added.
4.4	Requirement and test for compression resistance has been added.
4.2	Requirements and method of test for dimensions i.e. of internal length and flange width have been revised.
4.3	Requirement and test for impact resistance has been revised.

4. Consequent upon the issuance of the revised Standard, existing STI has been revised as Scheme of Inspection and Testing: **Doc: SIT/5852 (Pt. 1)/1 May 2019** which is being circulated separately.
5. The guidelines for implementation of the revised Standard is given below:

**A. LICENSEES:**

- (i) All Licensees shall implement the revised Standard by **23 Oct 2019**. BOs shall ensure that no Licences are under operation as per the old Standard after **23 Oct 2019**. **The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-2 within two weeks of the last date of concurrent running.**
- (ii) Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports or Test Certificates, as applicable.

Verification of implementation of the revised Standard, wherever required, may be done during the next visit **which may normally be completed within six months of the last date of concurrent running.**

- (iii) If the Licensee fails to complete all actions by **23 Oct 2019** it shall be dealt with as per the prevailing guidelines.

**B. APPLICATIONS FOR GRANT OF LICENCE:**

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall from such Applicants also be obtained that in new test requirements, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto **23 Sept 2019** and for such cases Applicant shall give a declaration that they will implement the revised Standard by **23 Oct 2019**.
- (iii) Beyond **23 Oct 2019** no Licence shall be granted as per the old Standard.

**C. CHANGE IN SCOPE OF LICENCE:**

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only upto the date of implementation of the revised Standard or upto **23 Oct 2019** whichever is earlier.

6. The above guidelines come into force with immediate effect.
