Subject: Guidelines for implementation of IS 8144:2018

- 1. IS 8144:1997 has been revised as IS 8144:2018 and is published. With the publication of this Standard IS 9128:1999 is superseded and hence shall be withdrawn. There will, thus, be only one Standard i.e. IS 8144:2018 covering all types of Zinc Carbon batteries of different sizes namely R03, R6, R14 and R20 for various applications. The last date for implementation of IS 8144:2018 is 19 October 2018 after which IS 8144:1997 and IS 9128:1999 shall stand withdrawn.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about the revised Standard and shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.
- 3. Consequent upon the issuance of the revised Standard, existing STI has been revised as DOC: STI/8144/6, May 2018.
- 4. The guidelines for implementation of the revised Standard is given below:

A. For Licensees:

- (i) All Licensees operating as per IS 8144:1997 and IS 9128:1999 shall switchover to the revised Standard by 19 October 2018. BOs shall ensure that no Licences are under operation as per the old Standards after 19 October 2018.
- (ii) Licensees shall confirm conformance to the additional/modified requirements through In-house/ Independent Test Reports or Test Certificates, as applicable. Verification of additional requirements and facilities, if any, may be done during the next visit.
- (iii) BO may issue endorsement for the revised STI after receipt of STI Acceptance and the confirmation from the Licensee on implementation of the revised Standard. If the Licensee fails to complete all actions by 19 October 2018 it shall be dealt with as per OMPC.
- (iv) Licensees who have licence for both IS 8144:1997 and IS 9128:1999 may be given an option to retain any one Licence. The varieties covered in the other Licence shall then be included in the scope of the retained Licence and thereafter the other Licence shall be cancelled.

B. For Applicants:

(i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory as on date of issue of these guidelines may be processed as per the old Standards. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration from the Applicant may be obtained to that effect and the Application may be processed accordingly. An undertaking from

such Applicants shall also be obtained that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.

- (ii) Applications which are recorded henceforth may be processed as per the old Standards or the revised Standard. Processing of Applications as per old Standards shall be permitted only upto 19 October 2018 and for such cases Applicant shall give a declaration that they will switchover to revised Standard by 19 October 2018.
- (iii) For any Application which is processed as per the old Standards, Applicant shall give a declaration that they will switch over to the revised Standard by 19 October 2018.
- (iv) Beyond 19 October 2018 no Licence shall be granted as per the old Standards.

C. For Inclusions:

- (i) For Inclusion of New Varieties, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of Inclusions as per the old Standards shall be permitted only upto the date of switchover to the revised Standard or upto 19 October 2018 whichever is earlier.
- 5. The above guidelines come into force with immediate effect.
