**Subject: Guidelines for Implementation of Amendment No. 2 to IS 13334 (Part 2) : 2014, Specification for Skimmed Milk Powder Part 2 Extra Grade.**

1. Amendment No. 2 to IS 13334 (Part 2) : 2014 has been published. The last date for implementation of the amendment is **02 September 2020**.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.
3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause no.	Requirement
Clause 6.1.2	The existing clause has been replaced by the following: “The product may be packed in quantities of 25 kg in bags of food grade polyethylene (see IS 10171) of minimum thickness 0.05 mm. The bags should be properly closed by tying with a string or a rubber band or heat sealed and shall be subsequently encased in multi-walled kraft paper, such as crepe kraft paper bags of not less than 80 g/m <sup>2</sup> (GSM) grade, appropriately lined and having two or more inner layers of plain kraft paper of not less than 80 g/m <sup>2</sup> (GSM) grade.”
Annex A, IS 11824	Delete.

4. There are no changes in the existing SIT.
5. The guidelines for implementation of the amendment is given below:

### **A. LICENSEE:**

(i) All licensees shall implement the amendment by **02 September 2020**. BOs shall ensure that no Licences are under operation as per IS 13334 (Part 2) : 2014 without the amendment after **02 September 2020**. **The status of implementation of the amendment shall be confirmed by Head (BO) to CMD-II within two weeks of the last date of concurrent running.**

### **B. APPLICATIONS FOR GRANT OF LICENCE:**

(i) Existing Application where sample has been submitted in the Laboratory/Test Report has been issued by the laboratory may be processed without consideration of the amendment.

(ii) Applications which are recorded henceforth shall be processed with or without consideration of the amendment. Processing of Application without consideration of the amendment shall be permitted only up to 02 September 2020 and for such cases Applicant shall give a declaration that they will implement the amendment by 02 September 2020.

(iii) Beyond 02 September 2020, no Licence shall be granted without consideration of the amendment.

**C. CHANGE IN SCOPE OF LICENCE:**

(i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.

(ii) However, processing of such applications for change in scope of licence without consideration of the amendment shall be permitted only upto the date of implementation of the amendment by the licensee or upto 02 September 2020 whichever is earlier.

6. The above guidelines come into force with immediate effect.
