ITEM 0 WELCOME

- **0.1** Member Secretary, Shri Priyanshu Sharma welcomed and thanked all members for attending the 14th Meeting of LITD 19 sectional committee.
- 0.2 The Chairperson formally welcomed all the participants and was delighted to observe such rich participation from all members across various ISO/IEC working groups and the recently concluded SC 36 plenary sessions. New project proposals were introduced, prompting the committee to anticipate feedback on their progress. Valuable insights emerged from discussions, particularly regarding the impact of generative AI on areas such as E-Learning and content development, sparking considerations for existing standards. Dr. Jyotsna Kumar Mandal, convener of SC 36/WG 7 on Culture, Language, and Individual Needs, was commended for the significant contributions beyond the agenda, with a request for sharing the latest inputs provided to the ISO secretariat.

After a brief introduction of the members present, Member Secretary took upon the formal agenda items.

ITEM 1 FORMAL CONFIRMATION OF THE MINUTES OF THE LAST MEETING

1.1 There being no comments received from the members, the committee formally **confirmed** the minutes of the last (13th) meeting of 'E-Learning' Sectional Committee, LITD 19, which was held on 14th November 2023.

ITEM 2 ISSUES ARISING OUT OF THE PREVIOUS MEETINGS

The committee noted and appreciated the progress report of the action items from the previous meeting, given in item 2 of the agenda.

ITEM 3 SCOPE & COMPOSITION OF COMMITTEE

- **3.1** The committee reviewed the scope and composition of LITD 19 given in Annex-1 & the panels given in Annex-2 of the agenda.
 - The committee **decided** to modify the Scope & Title of panel 1 to "Review of three Drafts on Code of Practice for Designing Online Course Contents and Quality Assessment of Course Content and Delivery Platform"
- 3.2 The committee noted the co-option request given in 3.2 of the agenda. Since Dr. Malateshgouda Karegoudar was not present in the meeting, it was decided to take up his co-option request in the next meeting. The committee also emphasized that any co-option shall only be taken up when the expert attends the meeting, if invited. Dr. Malateshgouda Karegoudar needs to attend the next meeting as an invitee, otherwise his co-option will be rejected.
- **3.3** The committee noted the nomination given in item 3.3 of the agenda and formally welcomed (Dr. Sanjay Kumar Dhurandhar) from NIELIT to the Committee.
- **3.4** The committee noted the information given in item 3.4 of the agenda and Member Secretary was requested to follow up with IIM Bangalore for co-option.
- 3.5 The committee noted the information given in item 3.5 of the agenda. Since Shri Srikanth Chandrasekaran is leading the overall IEEE in Indian and due to his busy schedules he was not present in the last two committee meetings. The Chairperson (Dr. N Sarat Chandra Babu) volunteered to seek participation from IEEE.

3.5 It was noted that the attendance of IGNOU was 3/3 in the previous 3 meetings.

ITEM 4 UPDATE FROM PANELS UNDER LITD-19

4.1 Panel 1

The committee noted the comments received during the wide circulation on the three drafts on "Code of Practice for Designing Online Course Contents and Quality Assessment of Course Content and Delivery Platform". On further deliberation of the comments, the committee recommended few technical modifications along with the editorial correction as received on the comments during the wide circulation. The committee finalized the three drafts for publication as Indian standards and the project editor was requested to incorporate the changes and share the revised drafts with the Member Secretary. On receipt of the revised drafts, the Member Secretary was **requested** to review the changes as recommended by the committee and send the three drafts for publication as Indian standards.

4.2 Panel 2

The committee deliberated and noted the comments received during the preliminary draft period. Since all the comments were editorial in nature, the committee accepted all the P-draft comments and **requested** the Member Secretary to circulate the draft on "Requirements for E-text books in Education" in Wide circulation for a period of 60 days, after incorporating the comments received during the preliminary draft period.

4.3 Panel 3

The committee again reviewed the modifications made in the revised WC document and it was emphasized that the revision should refrain from mentioning any specific Act/Rule in the draft since different situations may adhere to different acts/ rules.

In view of the above, after having detailed discussion on this topic, the committee **decided to** incorporate the following statement in Clause 7.4 of the draft:

"Conformance has to be ensured to the applicable Act/Rule. In case violation happens, the Institution/an Individual may be liable under the applicable statute"

and delete the following statement from Clause 7.4 of the draft:

"In case violation happens in Data privacy and protection, despite consent, the Institution and/or an Individual is liable under Section 66E of IT Act".

It was **decided** to circulate the modified draft in Wide circulation for a period of 60 days inviting inputs & comments.

ITEM 5 REVIEW OF PUBLISHED/UNDER DEVELOPMENT STANDARDS

5.1 Review of Published Standards

The committee reviewed the standards listed in agenda item 5.1 and **recommended** to reaffirm the following standard for another period of three years since these are important standards. The committee further emphasized that if any inputs/comments are received before the due month of review, they may be considered and again taken up for review by the committee. ITEM 6 GUIDELINES FOR RESEARCH & DEVELOPMENT (R&D) PROJECTS FOR THE FORMULATION AND REVIEW OF STANDARDS INVITING POTENTIAL R&D PROJECTS FROM THE COMMITTEE MEMBERS

The committee noted the information given in item 6 of the agenda and reviewed the proposal received on "Development of Augmented Reality (AR)/Virtual Reality (VR) Enhanced e-Learning module for Understanding Electric Vehicle Battery test Standards by Public and Industry professionals". The committee felt that the submitted ToR was more of an application of "E-Learning" and may be more relevant to other technical committees of BIS (ETD or TED departments). In view of the above, the proposer was again requested to do the background review for the technical committee where the project is most relevant and propose it there.

The committee also emphasized on the fact that the proposed R&D projects should be, as far as possible, aligned with existing standards or useful in developing new standards.

The committee members were encouraged to submit potential R&D projects & their associated ToR for the consideration & review by the committee.

8.3.1 Debriefing from last Meeting of JTC 1/SC 36

The following members from the Indian delegation members provided the brief of their participation:

- ➤ Shri M. Kumar (CDAC) informed that in SC 36/WG 4, it is planned to initiate a study to identify use cases, new work items, and the requirements for "Metaverse for LET (Learning, Education and Training)" with initial composition of 3 members. Mr Kumar is one among them).
- ➤ Dr. Jyotsna Kumar Mandal (University of Kalyani) informed that he led the SC 36/WG 7 discussions as the Convenor of the group and shared his experience as new convenor of WG 7. He also touched upon the new work items in WG 7 and also provided presentation on closing plenary session of SC 36, requesting more participation from Indian experts in the WG 7.
- Shri Mohit Shukla (TCS) informed that he provided inputs towards online course resource integration. This involves connecting two systems, allowing one system to access a course resource from another, addressing aspects like attributes, APIs, and user authentication methods in SC 36/WG 9. He provided his inputs during the WG 9 meetings and the project leader has shared the revised drafts with him for further review.

The committee appreciated the enriching work being done by our experts in this committee and requested

them to continue their active involvement and participation in the national and international standardization efforts.

Further, the committee requested the Indian delegates who attended the recent SC 36 Plenary & WG meetings working groups meeting to share their brief participation report at an early date to the BIS secretariat for committee consideration. This will be useful for the SC 36 Indian National Mirror Committee (LITD 19) to be prepared in advance.

8.3.2 Upcoming Meeting of JTC 1/SC 36

The committee noted the information pertaining to the 41st plenary meeting of JTC 1/SC 36, scheduled to be held during 19-27, September, 2024. Since the agenda for the meeting is yet to be published, the Member secretary was requested to circulate the agenda for the meetings once it is available.

The committee **decided** to finalize the Indian delegation and the Indian contributions for the upcoming Plenary meetings in the next committee meeting.
