#### **ITEM 0 WELCOME**

- 0.1 Member Secretary extended welcome to all participants. He informed that Dr. Pushpak Bhattacharyya Chairperson LITD 30 is still recovering so he would not be able to participate in today's meeting. He has suggested that Dr. C Anantaram may chair today's LITD 30 meeting. Dr. C Anantaram and the committee agreed to the suggestion. Member Secretary expressed gratitude to Dr. C Anantaram and the committee.
- 0.2 Member Secretary provided a brief overview of standardization activity and work being carried out. Presentation is given in **Annex-2**.

#### 4.6.1 Twelfth plenary and working group meetings of JTC 1/SC 42

**4.6.1.1** Twelfth plenary and working group meeting was held as per following schedule in Vienna, Austria during 16th - 20th October 2023 (face to face meeting with best efforts being made relative to remote participation):

Member secretary suggested that he would share information related to under development documents of JTC 1/SC 42 and accordingly members should identify the projects and start contributing. Members were requested to consider the documents as given in **Annex-3 and Annex-4**. Delegates debriefed the updates of the Plenary and WG meetings. Indian delegation's participation in the ISO/IEC JTC 1 SC42 Plenary meet in Vienna was described by the delegates. There was general discussion regarding our proposals and the overall meeting. It was noted that India's Potential NWIP on Guidance for Generative AI Applications was well received and assigned to WG4 as a Study Item by the Plenary. Updates are given in **Annex-5**.

Regarding update related to EU AI act and EU commission's request to CEN-CENELAC to provide standards for EU AI act Dr. Avik conveyed following:

He informed that India has presidency of Global Partnership on Artificial Intelligence – GPAI (GPAI) and has mandate from G-20 to come up with common framework for responsible AI. He suggested to have workshop to discuss further w.r.t EU AI act, Standardization activities and GPAI' activities. He informed that he is part of all these initiatives. The committee requested Dr. Avik to provide further details to plan such workshop/discussion.

Members were also requested to consider and inform their plan of participation in next SC 42 Plenary and WG meeting which is scheduled to be held during 22nd -26th April 2024 at Seoul, Korea.

Dr. Amit Sata informed that he is considering proposal for 'Metaverse enabled Manufacturing system' and 'Block chain enabled IIoT for Manufacturing". He informed that they have setup lab at their university. He enquired about the timeline of submission. Member secretary informed that this is a continuous exercise and accordingly he can submit proposals. He also enquired about the related committee of LITD to which proposal should be submitted.
