#### ITEM 0: WELCOME ADDRESS

- 0.1 The Member Secretary extended a warm welcome to the participants.
- 0.2 After introduction of the members, the Member Secretary requested the Chairperson to kindly initiate the proceedings.
- 0.3 Prof. G. Siva Kumar, Chairperson LITD 31 welcomed the participants. He expressed that it was encouraging that the committee was meeting as per the schedule decided in the fifth meeting. He urged members to contribute meaningfully to the formulation of standards under this committee.

#### ITEM 1: FORMAL CONFIRMATION OF THE MINUTES OF LAST MEETING

1.1 The Member Secretary informed that the minutes of the 5th meeting of the committee held on 02.05.2023 were circulated on 13.06.2023. No comments were received on the minutes. Hence, the committee formally confirmed the minutes of the fifth meeting.

## ITEM 2: SCOPE AND COMPOSITION OF LITD 31

2.1 The member secretary informed that she was still in the process of reaching out to the organizations in the committee and seeking nominations and the process would require some



time. Therefore, it was proposed to take up review of scope and composition of the committee in subsequent meeting planned after ISO/IEC JTC 1/SC 38 plenary planned in September, 2023. The committee formally agreed.

#### ITEM 3: INTERNATIONAL STANDARDIZATION ACTIVITIES

### 3.1 The committee noted item 3.1 of the agenda.

Member Secretary informed that most of the members nominated as experts in the SC38 working groups were not attending the meetings. It was emphasized that attending the working group meetings and contributing in the projects going on in the working groups is the of utmost importance. List of projects going on in JTC 1/SC 38 and JTC 1/SC 39 working groups was shared with the members present (Placed in **Annexure-1**). Member secretary also requested the committee members and the nominated experts to focus especially on the documents which were in NWIP stage (Stage- 20.00) as there was a lot of scope for contribution and discussion in these documents.

It was also decided that while the review of composition is taken up by the committee, membership in the various groups for JTC 1/SC 38 and JTC 1/SC 39 will also be reviewed and the non-participating experts and experts who are not providing regular updates would be removed from the respective working group of JTC 1/SC 38 and JTC 1/SC 39. Schedule of upcoming meetings until September, 2023 plenary for JTC 1/SC 38 was also shared with the committee to ensure better participation by experts (Placed in **Annexure-2**).

### 3.2 Adoption of standards published by ISO/IEC JTC 1/SC 39:

The committee reviewed documents listed in Annexure 2 as per the item 3.2 of the agenda. The committee agreed to finalise the documents and approved the documents to be sent for publication. The committee further decided to create a group of experts to analyse the possible impact of the ISO/IEC 30134 series standards being adopted on the existing data centers.

Further, chairperson emphasized that development of projects from India need to be a collective effort and asked the committee members to have an active participation in the development of project.
