विषय: Instructions on drawal and sending samples for testing.

This has reference to the minutes of ROs-BOS meeting held on 11&12-12-2017. As per point 6.4 of the minutes, the following was discussed:

"As per the practice being followed at present, in case where BIS labs have partial testing facility, samples are first sent to BIS labs and then BIS labs divert the samples to OSLs for the parameter for which testing facilities are not available with them. In this process a lot of time is consumed. It was therefore decided that the existing provisions may be reviewed for providing an option to BO to send such samples to OSLs directly"

- 2. At present, the office order Ref: LPPD/5:1/Issue No 18869 dated 03-02-2016 on the subject Instructions on drawal and sending samples for testing is being followed. As per point no 13 of the said order:
- "13. In situation where testing facilities for some parameters are not available with BIS labs, particularly for priority samples, the inspecting officer should ensure drawl and submission of separate additional samples to BIS Labs.BIS Labs in turn would get these requirements (for which test facilities are not available in BIS Lab) tested simultaneously from any other lab on rotation basis.BIS Labs on their part shall ensure issuance of complete test report to BOs in such cases. This will ensure optimal utilization of BIS labs."
- 3. Competent authority has approved the following modified point 13 in the said order:
- "In situation where testing facilities for some parameters are not available with BIS labs, the inspecting officer should ensure drawal and submission of separate additional samples directly to OSLs for requirements for which testing facilities are not available in BIS Labs. Samples would continue to be sent to the BIS Labs for the partial requirements for which test facilities are available in BIS Labs".
