Subject: Testing of BIS Samples at the laboratories of M/s National Test House

Kind attention of all concerned is invited to earlier orders on the captioned subject dated 7<sup>th</sup> Jan 2016 & 31 August 2020 regarding utilization of BIS recognized laboratories for the purpose of testing of BIS samples.

The Department of Consumer Affairs (DoCA) vide their letter no. J-11011/19/2020-NTH Dated 4<sup>th</sup> Sep 2020, addressed to DG BIS, has informed that in the meeting of the Executive Committee of NTH, held on 14<sup>th</sup> Aug 2020 under the chairmanship of MoS(CA, F & PD), a point was raised that BIS should allocate more samples for testing to NTH in context with its business development through Government Labs.

In view of the above, all BIS labs and ROs/BOs are advised to prioritize forwarding of BIS samples for independent testing to BIS recognized laboratories as per the following criteria provided the required test facilities are not available in BIS labs:

- i) NTH labs
- ii) Other Govt labs
- iii) Labs other than i) & ii) above
