10.1 The committee noted the information given at Item No. **10.1** to **10.4** of the Agenda.

10.2 Under ISO TC 17/SC9 name three standards are under development in which active participation is being done by Indian delegations comprising of members from Tata Tinplate, JSW coated steels etc. The Indian delegation is attending all the meetings of this subcommittee since more than a decade. It was proposed that the next-to-next meeting of ISO TC 17 SC 9 may be held in India in 2025 after the meeting scheduled this year in Germany. This will help in larger participation of Indian delegation and better understanding among the BIS committee members about the working of ISO technical committees. The committee after deliberation agreed and decided that India should organize the plenary meeting of ISO TC17/SC9 in 2025.
