- Date of receipt of Detection : 07 August 2024
- Brief description of the case : M/s. Madhu Home Appliances, 7-Vashisht Nagar, Babyal Road, Ambala Cantt, Haryana- 133 001 was manufacturing Domestic Electric Food Mixer and Hand-held Blender without BIS Standard Mark  Mark.
- Source of Information : Complaint was received by DDGN through email dated 14 July 2024 which was forwarded to PRBO by DDGN through email on 19 July 2024
- Provision of BIS Act, 1986 violated : Section 16 (1) (a) and 17(1)(a) of BIS Act, 2016
- Type of Violation (Refer circular CAD/Gen/25 dated 01.10.2018 ) : Manufacture, import, distribute, sell, hire, lease, store or exhibit for sale goods, article, process, system or service which is under mandatory certification without a Standard Mark (with or without a valid license or license under suspension/ deferment /dormancy): a) Where BIS is the Enforcing Authority.  
(Sl. No. 8 of Annex-II of Guidelines for Dealing with Violations of BIS Act 2016 vide CMED/Gen/5 dated 26-May-2023)
- Remarks, if any : Firm doesn't have any valid license number for manufacturing and packing of Domestic Electric Food Mixers and Hand-held Blenders. During search and seizure operation, 648 Nos of Domestic Electric Food Mixer and 279 Nos of Hand-held Blenders bearing Rating-550 W, Brand Name- Madhu, manufactured by Madhu Home Appliances, 7-Vashisht Nagar, Babyal Road, Ambala Cannt, Haryana- 133 001 were found available.  
  
Out of the above materials, the following materials were seized, tagged, signed, wax-sealed with BIS seal no 586 and left with the firm for keeping in safe custody along with the Supradari letter:  
  
(i) 647 Nos of Domestic Electric Food Mixers-coded as HYBO/SP/GPY/20240904/Enf/01  
(ii) 278 Nos of Hand-held Blenders-coded as HYBO/SP/GPY/20240904/Enf/02

01 No from each of the above varieties i.e. 1 No. of Domestic Electric Food

Mixers and 01 No. Hand-held Blenders were brought to PRBO as evidence under safe custody.
