- S.O. 4252(E).—In exercise of the powers conferred by sub-sections (1) and (2) of section 16 read and sub-section (3) of section 25 of the Bureau of Indian Standards Act, 2016 (11 of 2016), the Central Government, after consulting the Bureau of Indian Standards, is of the opinion that it is necessary or expedient so to do in the public interest, hereby makes the following Order, namely:-
 - Short title and commencement. (1) This Order may be called the Helmet for riders of Two Wheeler Motor Vehicles (Quality Control) Order, 2020.
 - (2) It shall come into force with effect from 01st June 2021.
 - 2. Compulsory use of Standard Mark.- Goods or articles specified in column (1) of the Table shall conform to the corresponding Indian Standard specified in column (2) of the said Table and shall bear the Standard Mark under a license from the Bureau of Indian Standards as per Scheme-I of Schedule-II of BIS (Conformity Assessment) Regulations, 2018:

Provided that nothing in this Order shall apply to goods and articlesmeant for export.






