#### **FOREWORD**

Release base paper is used for the manufacture of release paper, which in turn is used for pressure sensitive labels, stickers for rubber products, food products, plastic products and petrochemical products. Usually, super calendered sulphite base paper is utilized for the preparation of release base paper. It is also known as silicone base paper.

A scheme for labelling environment friendly products to be known as ECO-Mark was introduced in the standard at the instance of the Ministry of Environment, Forests and Climate Change (MoEF&CC). The ECO-Mark is administered by the Bureau of Indian Standards (BIS).

Considering the recent technological advancements, the Committee decided to revise this standard.

In this first revision, the following modifications have been incorporated:

- a) The references clause has been updated;
- b) The product has been categorised into two grades based on manufacture and grammage of paper. The description clause for these two grades have also been introduced;
- c) Requirements for Gurley Porosity, Smoothness, Bendsten, Tear index, and Burst index have been updated;
- d) A new requirements of Gloss has been incorporated
- e) The test methods have been updated; and
- f) The amendments have been amalgamated.

This standard contains **6.1.1** which call for agreement between the purchaser and the supplier.

# RELEASE BASE PAPER — SPECIFICATION

(First Revision)

#### 1 SCOPE

This standard prescribes requirements and methods of sampling and test for release base paper intended for the manufacture of release paper.

#### 2 REFERENCES

The standards listed in Annex A contain provisions, which through reference in this text, constitute provisions of this standard. At the time of publication, the editions indicated were valid. All standards are subject to revision and parties to agreements based on this standard are encouraged to investigate the possibility of applying the most recent edition of these standards.

#### 3 TERMINOLOGY

For the purpose of this standard, the definitions of terms given in IS 4661 (Part 4) shall apply.

#### 4 GRADES

The release base paper shall be of following two grades:

- a) Grade 1 Glassine release base paper with gmmmage 40 gsm to 120 gsm; and
- b) Grade 2 Clay coated kraft (CCK) release base paper with grammage 60 gsm to 120 gsm.

# **5 REQUIREMENTS**

#### 5.1 General

**5.1.1** The release base paper shall be free from pin holes, slime holes, stock lumps, wrinkles, calender cuts, dirt particles and colour marks.

# **5.1.2** Glassine Papers

The glassine papers shall be super calendered with uniform caliper, high transparency and siliconisable on both sides. It may be in multiple colours,

#### 5.1.3 CCK Papers

It shall have good dimensional stability, uniform caliper, low hygro expansion with clay coating on front side. It may be matt finish or gloss finish.

### 5.2 Grammage (Substance)

**5.2.1** The grammage of the release base paper shall be as follows when tested according to the method prescribed in IS 1060 (Part 5/Sec 5):

- a) Grade 1  $40 \text{ g/m}^2$  to  $120 \text{ g/m}^2$ ; and
- b) Grade 2  $60 \text{ g/m}^2$  to  $120 \text{ g/m}^2$
- **5.2.2** No test result obtained from individual test piece shall vary by more than  $\pm$  6 percent of the nominal grammage. Further, the mean of 10 test results shall not vary from the nominal grammage by more than  $\pm$  4 percent.
- **5.3** In addition to the above requirements, the paper shall also comply with the requirements given in Table 1 when tested in accordance with the method referred to in co1 (5) of Table 1.

# 5.4 Additional Requirements for ECO Mark

# **5.4.1** General Requirements

The product shall conform to the requirements for quality and performance prescribed under 5.1 to 5.3.

**5.4.2** The manufacturer shall produce to BIS, the environmental consent clearance from the concerned state Pollution Control Board as per the provisions of *Water (Prevention and Control of Pollution) Act*, 1974 and *Air (Prevention and Control of Pollution) Act*, 1981 along with the authorization, if required under the *Environment (Protection) Act*, 1986 and the Rules made thereunder, while applying for ECO-Mark.

#### **5.4.3** Product Specific Requirements

The material shall be of the following varieties depending on the raw material used in the manufacture:

- a) The paper and paper boards manufactured out of pulp containing not less than 60 percent by weight of pulp made from materials other than bamboo, hardwoods, softwoods and reed; and
- b) Recycled paper and paper board must be made from 100 percent waste paper.'

#### 6 PACKAGING AND MARKING

#### 6.1 Packing

- **6.1.1** The paper shall be packed securely and suitably as agreed to between the purchaser and the supplier to ensure that the paper is not damaged due to handling and transportation.
- **6.1.2** For ECO-Mark, the product shall be packed in such packages which shall be recyclable/reusable or biodegradable.

#### 6.2 Marking

- **6.2.1** Each package or roll shall be marked with the following particulars:
  - a) Description including grade of the product;
  - b) Substance in g/m<sup>2</sup> of the paper;
  - c) Size of the paper. In the case of reels, width and length of the paper;
  - d) Lot number,
  - e) Month and year of manufacture; and
  - f) Indication of source of manufacture.

#### **6.2.2** BIS Certification Marking

The product(s) conforming to the requirements of this standard may be certified as per the conformity assessment schemes under the provisions of the *Bureau of Indian Standards Act*, 2016 and the Rules and Regulations framed there under, and the products may be marked with the Standard Mark.

**6.2.3** For ECO-Mark, following additional information may also be marked on the container/package:

'The criteria for which the product has been labelled with ECO-Mark.'

# 7 SAMPLING AND CRITERIA FOR CONFORMITY

## 7.1 Sampling

The paper shall be sampled in accordance with IS 1060 (Part 1).

# 7.2 Number of Tests

From each of the ream, selected from the lot (*see* **7.1**), one sheet shall be taken out at random. These sheets shall constitute the sample. The sheets selected shall first be tested for general requirements given in **5.1** and **5.2**. One test piece shall be cut from each sheet selected for each of the characteristics mentioned in **5.3** and Table 1, and tested. A sheet not meeting the requirements shall be considered as defective.

# 7.3 Criteria for Conformity

A lot shall be declared as conforming to all the requirements of this standard if the number of defective sheets found does not exceed the acceptance number. The acceptance number shall depend upon the size of the sample and shall be zero if the size is less than 13. The acceptance number shall be one if it is greater than or equal to 13.
