Subject: Concurrent Running of Indian Standards/Amendments

In exercise of the power conferred to DG, BIS by Rule 28 of BIS Rules 2018, to allow concurrent running of two versions of standards/amendments, the concurrency period of 6 months has been decided by DG, BIS for all standards/amendments.

Accordingly, the standard operating procedure for concurrent running period of standards/amendments is modified as under:

- a) Concurrency Period: **6 Months** for all standards/amendments.
 - i. Technical Departments shall provide the inputs related to standard(s) to be withdrawn/superseded (if any), while uploading the Divisional Council approval.
 - ii. File shall be put up by Publication Department to DG, BIS for the approval of draft gazette.
 - iii. These notifications once published in the Gazette of India, shall be circulated weekly to all Technical Departments and Central Marks Department(s).
- b) In case Central Marks Department (or any other department) decides to extend/reduce the concurrent running period for standards/amendments beyond/below 6 months, then the permission for extension/curtailment in the concurrent running period shall be taken by the concerned department from Competent Authority and same shall be communicated to Publication Department for gazette notification.

This SOP amends the portion related to concurrent running of Indian Standards/amendments given in office order Sc.G&CS Sectt/PUB dated 23.12.2013 read along with office order SPPD/G-6 dated 01.05.2019.
