As such, the Chairperson directed the Member Secretary to take the necessary steps to issue the standard for wide circulation for public feedback and comments.

The Member Secretary requested that Shri R. S. Chauhan furnish the draft standard on "Specification for Pneumatic Torque Wrench" as per the prior agreement. Shri R. S. Chauhan had committed to providing the document within 60 days following the circulation of the minutes.

Item 6 TECHNICAL ISSUES

During the meeting, the Member Secretary informed the committee of the 5-yearly periodic review of published Indian Standards. The committee discussed the standards that are due for review in the 2023-24

financial year. The Member Secretary offered to review the following Indian Standards, which are based on ISO 1180 Shanks for pneumatic tools and fitting dimension of chuck bushing, and provide the draft standard within 60 days following the circulation of the minutes.

- a) IS 6573:1987 Dimensions for pneumatic coal pick shanks and chuck bushings (*first revision*)
- b) IS 6574:1987 Dimensions for pneumatic river snap shanks parallel and chuck bushings (*first revision*)
- c) IS 6575:1987 Dimensions for pneumatic breaker and spade shanks and its chuck bushings (*first revision*)
- d) IS 7446:1987 Dimensions for chisel shanks and chuck bushings for pneumatic chippers (*first revision*)
- e) IS 7995:1994 Pneumatic concrete breaker shanks Dimensions (*first revision*)
