This has reference to the subject mentioned above.

The updated Product Manual for IS 398 (Part 5) for Aluminium Conductors, Galvanized Steel Reinforced used for Extra High Voltage Overhead power lines (400 kV and above) has been hosted on the BIS website under "Conformity Assessment → Product Certification → Product Specific Guidelines → Product Manual.

BOs are advised to send this Product Manual which incorporates Grouping Guidelines and modified SIT to all Licensees and Applicants within 7 days. The SIT which has been incorporated in the Product Manual shall be implemented within 30 days.

This updated Product Manual incorporates requirements for Galvanized Steel wire for the core of ACSR. As the Galvanized steel wires are to be treated as a variety within the same Licence, wherever manufacturing units are holding two separate Licences (for ACSR and galvanized steel wire for ACSR), these shall be merged into a single Licence. Licensees who have two licences as per IS 398 (Part 5) shall be given an option to retain any one Licence. The varieties covered in the other Licence shall then be included in the scope of the retained Licence and thereafter the other Licence shall be cancelled.

The above shall be complied with within 30 days.
