Subject: Revised Product Manual incorporating SIT and Grouping Guidelines for IS 1786 : 2008 'High strength deformed steel bars and wires for concrete reinforcement'

This has reference to the subject mentioned above.

IS 1786 : 2008 'High strength deformed steel bars and wires for concrete reinforcement' is under mandatory certification of BIS. Identification of manufacturer of HSDS bars/wires becomes very difficult at times while drawing market samples in case tag attached to bundle/coil gets misplaced. The matter has been examined and in order to have better traceability of the product, it has been decided that following details shall be marked on HSDS bars/wires at a distance of not more than 3 meter during rolling or by any other permanent means of marking:

- a) Brand name/Trade mark of manufacturer
- b) Grade of HSDS bars/wires
- c) Six digit identification number (First two digits are two digit Branch ID circulated vide CMD-II circular ref: CMD-II(L)/9 dated 20/10/2014, under whose jurisdiction the licence is in operation and last four digits are the last four digits of the licence number allotted to the manufacturer)

Considering the above, the product manual is revised as Doc: PM/IS 1786/2, May 2019. The approved revised Product Manual for **IS 1786 : 2008 'High strength deformed steel bars and wires for concrete reinforcement'** has been hosted on the BIS website under

“Conformity Assessment → Product Certification → Product Specific Guidelines → Product Manual.

BOs are advised to send this revised Product Manual, which incorporates Grouping Guidelines and modified SIT to all Licensees and Applicants within 7 days. The SIT, which has been incorporated in the revised Product Manual, shall be implemented **by 15/08/2019**
