Subject: Implementation of Product Manual Doc: PM/IS 458/1/December 2018 for certification of IS 458 : 2003.

This has reference to the above subject. Product manual doc: PM/IS 458/1/December 2018 was circulated by CMD-III on 12/12/2018 for implementation. As per IS 458 : 2003, conformity of reinforcement is required to be ensured as per relevant Indian Standard. HD wire as per IS 432 (Part 2) : 1982 is also used as reinforcement in manufacturing of precast concrete pipes, which is under mandatory certification of BIS as per Steel and Steel Products (Quality Control) Orders, 2019.

CMD-III received a representation from M/s Spun Pipes Manufacturing Association of Maharashtra with request for keeping implementation of product manual with SIT in abeyance citing non availability of ISI marked HD wire as per IS 432 (Part 2). They also informed that manufacturers of HD wire are not taking BIS licence for their product and hence supply position of 11 licensees as per IS 432 (Part 2) does not cater to the demand from more than 600 manufacturers of precast concrete pipes. However, as the HD wire as per IS 432 (Part 2) : 1982 is under mandatory certification, BIS cannot relax any provisions of the QCO and cannot grant permission to use non-ISI raw material.

In view of the above, BOs are requested to follow up with manufactures of HD wire located under their jurisdiction for making them aware about obtaining BIS licence. BOs are also requested to take appropriate action against manufacturers of HD wire who have not implemented the provisions of Steel and Steel Products (Quality Control) Orders, 2019.
