# Subject: Maintaining consolidated database of certification of coveralls, masks and eye protectors (PPEs)

- 1. This has reference to CMD-2's circular dated 28.05.2020 regarding maintaining consolidated database of certification of masks and eye protectors (PPEs)
- 2. In addition to the Shared sheets being maintained for IS 9473, IS 5983 and IS 16289, a shared sheet for Coveralls as per IS 17423 is also being maintained.
- 3. However, it has come to the attention of the Competent Authority that BOs are not updating the shared sheets regularly due to which it is proving difficult to provide up-todate information to the concerned Ministries/Department of the Central Government who are monitoring the certification of PPEs closely. This has been viewed seriously by the Competent Authority who has directed that henceforth, all BOs shall update and complete the details regularly on the sheets and the concerned DDGRs shall monitor the same.
- 4. In addition, 3 WhatsApp groups have also been created for coordination regarding certification of FFP2 masks (IS 9473), surgical masks and eye protectors (IS 16289 and IS 5983) and Coveralls (IS 17423). All BO heads are requested to get themselves and/or the concerned dealing officers added to the groups pertinent to the product for which they are processing applications or operating licences. In this regard, the undersigned or Shri Avik Datta, Sc-C, DDG (Cert.) Sectt may be contacted.
- 5. The links to the shared sheets for the above products are given below again for the access of the ROs and BOs. All BO heads requested to ensure that only the data pertinent to their applications/licences is edited without disturbing the other data in the sheet. Applying of filters and sorting of the table may please also be avoided.
