11	Detailed observations (including activities at the time of visit & facilities available)	 a) As per the information given in CMED complaint no V-17330 dated 12 March 2024, the raid-team reached the above location on 07.06.2024 at around 12:00 hrs. b) The warehouse was storing Polyester Staple Fibre(PSF) packed in Bales without BIS standard mark (ISI mark). c) The material seized was sealed as under: i) 1 bale of Polyester Staple Fibre(PSF), wax sealed with BIS wax seal no 467 and coded as CNBO/65501/20240606/ENF/2 has been brought to office as material evidence of misuse ii) Remaining 13 bales of Polyester Staple Fibre(PSF) seized, and coded as CNBO/65501/20240606/ENF/2 have been left with the firm under Supradari Refer ANNEX-C and ANNEX-D for Seizure memo and Superdari respectively. d) These items were sealed in the presence of in-charge of the warehouse Shri. M Karthick. Photographs of the products seized, duly signed by the proprietor of the firm enclosed as evidence and given at ANNEX – E.

		e) As informed by the ware house in-charge, the stock movement register of warehouse was examined and found out that the stock of PSF stored in their premises was owned by M/s Precious Polytechnic (GST No. 33AQWPP5824H1ZC), No.8, Bharathiyar Street, Ponni Nagar, Pammal, Kancheepuram, Tamil Nadu, 600075. f) Also, screen shots from the stock movement register of warehouse(ANNEX-F) and in-ward pass No.66 dated:16.05.2024(ANNEX-F) were collected as evidence to establish both the storage and transport of 66 bales PSF by M/s Precious Polytechnic at the warehouse. As 52 bales were already transported since 16 May 2024, the remaining stock of 14 bales were seized. Among those 14 bales, 13 were seized and left at the warehouse and 1 bale was seized and taken along with us to CNBO, BIS. g) Further, screen shots from the stock movement register of warehouse was obtained as evidence to establish both the storage and
