Subject: Temporary measures for Renewal of Licence (RoL) on self-declared production statement basis under conformity assessment Scheme - I () - reg.

- 1) Bureau of Indian Standards (BIS) is operating product certification scheme to grant licence for use of Standard Mark (as per Scheme I of BIS (Conformity Assessment) Regulations, 2018.
- 2) Under Scheme I, Licence may be considered for renewal for a period of minimum one year and upto five years on the request of the licensee, depending upon whether the application fee, licence fee, advance minimum marking fee and dues, if any, has been paid for requested duration along with the renewal application. The application for RoL shall be made in Form XII annexed to this Scheme I which stipulates submission of production statement duly authenticated by CEO/authorised signatory of the licensee.
- 3) Scheme I of BIS (Conformity Assessment) Regulations, 2018 permits RoL on the basis of production statement duly authenticated by CEO/authorised signatory of the licensee. As an additional verification/validation measure, the guidelines for RoL Ref: CMD-I/2:12:3 dated 29 October 2018 specifies due authentication on letter head of the chartered accountant/cost accountant (CA).
- 4) Due to prevalent extraordinary situation of lockdown declared by the Central Government to contain the spread of COVID-19 and issues as highlighted during RO/BO meeting dated 15 April 2020, offices of the CA firms are closed and licensee desirous of applying for renewal are unable to do so due to unavailability of means to submit CA authenticated production statement.
- 5) In view of the current situation prevailing in the country due to lockdown and the issues brought out above, following temporary measures are issued in the Guidelines for Renewal of Licence:
 - Applications for renewal of licence may be processed on the basis of submission of production statement duly authenticated by CEO/authorised signatory of the licensee subject to compliance with all other provisions of Regulations and Guidelines.
 - Provided the licensee submits an undertaking as per Annexure I to submit the CA authenticated production statement within 30 days of lifting of the lockdown failing which their license may be put under suspension.

- ii) Such relaxation shall be available during the period of this lockdown only.
- iii) Head BOs shall maintain log of all such cases for ensuring compliance after lifting of the lockdown.
- iv) DDGRs shall ensure close monitoring of all such cases in their regions.
- 6) This issues with the approval of the Competent Authority.
