## FOR POWDER HAIR DYES ACCORDING TO IS 10350:2020

- **1.LABORATORY** A laboratory shall be maintained which shall be suitably equipped (as per the requirement given in column 2 of Table 1) and staffed, where different tests given in the specification shall be carried out in accordance with the methods given in the specification.
- **1.1**The manufacturer shall prepare a calibration planfor the test equipments.
- **2. TEST RECORDS** –The manufacturer shall maintain test records for the tests carried out to establish conformity.
- **3. PACKING AND MARKING** The Standard Mark, as given in the Schedule of the licence, shall be marked on the container or the label applied to it provided always that material so marked conform to requirements of the specification.
- 3.1 Packing and Marking shall be done as per the provisions of the Indian Standard. In addition, the following shall be incorporated on each container:
  - i)BIS Licence Number CM/L .....and
  - ii)BIS website details i.e. "For details of BIS certification please visit www.bis.gov.in".
- **5. CONTROL UNIT** For the purpose of this scheme, Powder hair dyes of one type blended at a time shall constitute one Control Unit.
- **5. LEVELS OF CONTROL** The tests as indicated in column 1 of Table 1 and the levels of control in column 3 of Table 1, shall be carried out on the whole production of the factory which is covered by this plan and appropriate records maintained in accordance with paragraph 2 above.
- 5.1 All the production which conforms to the Indian Standards and covered by the licence should be marked with Standard Mark.
- **6. REJECTIONS**—Disposal of non-conforming product shall be done in such a way so as to ensure that there is no violation of provisions of BIS Act, 2016.
