1. In order to align the f-draft document on coaching center service - requirements (SSD 21128) with the Guideline for Regulation of Coaching Center recently published by Ministry of Education, the following modification have been made by BIS in the f-draft:

- definitions of coaching and coaching centers have been modified;
- A definition for proprietor has been added;
- provision for a coaching center website has been added;
- refund policy has been modified;
- clauses 9.2,9.3,9.4 have been added under design and learning services.

2. While reviewing the f-draft document, modifications have been made in the minimum qualification criteria of a faculty in coaching center to align the criteria with UGC guideline/notification.

The modified texts are in the blue color font.

The members of the Sectional Committee, SSD 04 are requested to kindly examine the final modified document and provide comments, if any by **23/02/2024**.

The document would be consider for publication after the approval of the Chairperson, SSD 04,
