Subject: Usage of "www.meesho.com" for selling products in contravention of Quality Control Order

- 1. There are several products notified by the Central Government that are prohibited to be sold, stored or exhibited for sale, without a BIS Standard Mark under a valid license from Bureau of Indian Standards (BIS). Such products are notified by the Central Government through various Quality Control Orders (QCOs) issued under BIS Act 2016. As per the Domestic Pressure Cooker (Quality Control) Order, 2020 use of BIS Standard Mark to compulsory for all Domestic Pressure Cooker manufactured, imported, distributed, sold, stored or exhibited for sale in India. Any contravention of this order is punishable under the provisions of BIS Act, 2016.
- 2. It has come to our notice, through market surveillance, that a seller on your e-commerce platform is exhibiting and selling a Domestic Pressure Cooker without the BIS Standard Mark (5). The details of the seller, product, page URL and invoice are given below:

- 3. The address specified in the invoice was visited by BIS and it was found that seller has specified an incorrect address on the invoice.
- 4. Since the seller is using your e-commerce platform for exhibiting and selling a product in contravention of the Quality Control Order of the Central Government, this amounts to a contravention of QCO by you as well. Moreover, address being used by the seller on the invoice has also found to be incorrect. In view of this, you are advised to delist the seller from your e-commerce platform and take other necessary actions to prevent the usage of your platform for sale of non-certified products falling under compulsory certification under BIS Act 2016. You are required to submit an explanation and action taken report within 15 days from the issuance of this letter.
