Hotel, Marve Road, Malad West Mumbai 400095 for the purpose of glass manufacturing Company

Operating Without Licenses.

The use of uncertified or substandard toughened glass poses significant safety risks to consumers, such

as glass breakage and injury. Furthermore, it undermines the credibility of established safety standards

that the BIS diligently work to uphold.

Requested Action:

I kindly urge you to take the necessary steps to investigate this matter thoroughly. If the product in question is indeed found to be non-compliant with BIS standards, I request that appropriate action be taken against the manufacturer/distributor/seller, including but not limited to:

Immediately seal all product and give stop production notice to manufacturer

Immediate recall of the non-compliant product from the market.

Imposition of penalties for non-compliance.

Public notice alerting consumers about the risks associated with using such products.

Mandatory certification enforcement for all future products.

I trust that BIS will handle this matter with the urgency it deserves to safeguard public health and safety. Please let me know if any further information is required to support this complaint.
