DRAFT AMENDMENT NO. 1 TO IS 17631 : 2022 WORK CHAIRS — SPECIFICATION

(*Page* 2, *clause* **4.3**) – Delete the existing clause.

(*Page 2, clause 5, Note*) – Substitute the following with the existing note:

'NOTE — Any other dimensions and design specifications of chairs may be used as agreed between the manufacturer and the purchaser or as declared by the manufacturer as per design requirements as per the design requirements.'

(*Page 2, clause* **6**, *title*) – Substitute the following with the existing:

'RAW MATERIALS REQUIREMENTS'

(*Page* 2, *clause* **6.1**) – Delete the existing clause.

(*Page* 2, *clause* **6.2**, *first paragraph*, *first sentence*) – Substitute the following with the existing:

'For fabric and/or leather (synthetic and natural) surfaces, the raw materials shall be tested for the following tests (as applicable) and shall conform the minimum performance requirements specified in IS 17637.'

(*Page* 2, *clause* **6.2**, *last paragraph*) – Substitute the following with the existing:

'The above mentioned tests shall be carried-out on raw materials (as applicable) used in manufacturing of the chair; not on assembled chair.'

(*Page 5, clause 7.4, title*) – Substitute the following with the existing:

'Strength Tests'

(*Page* 13, *clause* **A-1**, *second paragraph*, *first sentence*) – Substitute the following with the existing:

'All the safety tests shall be carried out on samples from same lot.'

(*Page* 13, *clause* **A-4**, *first sentence*) – Substitute the following with the existing:

'All applicable tests as mentioned in 7 shall be carried out on the samples from same lot and in the sequence as the clauses are numbered in each stability tests, strength tests and durability tests separately.'
