**DRAFT AMENDMENT NO. 1
TO
IS 17633 : 2022 TABLES AND DESKS — SPECIFICATION**

(Page 2, clause 4.2) – Substitute the following with the existing:

‘The exposed/ accessible edges and protruding parts shall be free from burrs, sharp edges and shall be rounded or chamfered. The ends of accessible hollow components shall be closed or capped. There shall be no exposed unfinished open surfaces. Movable and adjustable parts shall be designed so that injuries and inadvertent operations are avoided. In case wooden components, the same shall be free from any stain, unless it is from intended as part of design feature.’

(Page 2, clause 6, title) – Substitute the following with the existing:

‘RAW MATERIALS REQUIREMENTS’

(Page 2, Table 1, ^{a)} and ^{b)} in the end of table) – Substitute the following with the existing note:

^{a)} Work tables include tables used for seated and/or standing office tasks, for example, desks and panel/screen system supported tables.

^{b)} Other tables include meeting and conference tables, discussion tables, pantry tables.’

(Page 2, Table 2, title of column of 3) – Substitute the following with the existing note:

‘Small tables for decorative and/or light duty applications with a surface area $\leq 0.15 \text{ m}^2$ ^{c)}’

(Page 2, Table 2, title of column of 4) – Substitute the following with the existing note:

‘Tables ≤ 600 mm in height, or tables with tops with a surface area $\leq 0.25 \text{ m}^2$ ^{a)}’

(Page 17, Table 5, note 3 ^{a)} and ^{b)}) – Substitute the following with the existing note:

^{a)} Work tables include tables used for seated and/or standing office tasks, for example, desks and panel/screen system supported tables.

^{b)} Other tables include meeting and conference tables, discussion tables, pantry tables.

(Page 18, Table 6, title of column of 3) – Substitute the following with the existing note:

‘Small tables for decorative and/or light duty applications with a surface area $\leq 0.15 \text{ m}^2$ ^{c)}’

(Page 18, Table 6, title of column of 4) – Substitute the following with the existing note:

‘Tables \leq 600 mm in height, or tables with tops with a surface area \leq 0.25 m^{2 a)}’

(Page 18, Table 6, title of column of 6) – Substitute the following with the existing note:

‘Small tables for decorative and/or light duty applications with a surface area \leq 0.15 m^{2 c)}’

(Page 18, Table 6, title of column of 7) – Substitute the following with the existing note:

‘Tables \leq 600 mm in height, or tables with tops with a surface area \leq 0.25 m^{2 b)}’

(Page 19, clause 9.1) – Insert the following at the end:

‘e) Performance category of tables and desks that is office tables, domestic tables and decorative/ light duty purpose tables’

(Page 20, clause A-1, second paragraph, first sentence) – Substitute the following with the existing:

‘All the safety tests shall be carried out on samples from same lot.’

(Page 20, clause A-4, first sentence) – Substitute the following with the existing:

‘All applicable tests as mentioned in 7 shall be carried out on the samples from same lot and in the sequence as the clauses are numbered in each stability tests, strength tests and durability tests separately.’
