NATIONAL FOREWORD

This draft Indian Standard (Part 4) which is identical with ISO/IEC TS 20748-4:2019 'Information technology for learning, education and training — Learning analytics interoperability — Part 4: Privacy and data protection policies' issued by International Organization for Standardization (ISO) and International Electro technical Commission (IEC) jointly, will be adopted by the Bureau of Indian Standards (BIS) on the recommendations of the E-Learning Sectional Committee, and approval of the Electronics and Information Technology Division Council.

The text of the ISO/IEC Standard *may be* approved as suitable for publication as an Indian Standard with the agreed modifications as indicated below. Certain conventions are, however, not identical to those used in Indian Standards. Attention is particularly drawn to the following:

a) Wherever the words 'International Standard' appear referring to this standard, they should be read as 'Indian Standard'.

b) Comma (,) has been used as a decimal marker while in Indian Standards, the current practice is to use a point (.) as the decimal marker.

"Conformance has to be ensured to the applicable Act/Rule. In case violation happens, the Institution/an Individual may be liable under the applicable statute"
