

3 MATERIAL

Stainless steel of Designation 20Cr13 of IS 6603.

4 SHAPE AND DIMENSIONS

As shown in Fig. 1

5 HEAT TREATMENT

Shall be hardened and tempered to 400 to 450~HV.

6 WORKMANSHIP AND FINISH

- **6.1** The hammer shall be formed in one piece.
- **6.2** The surfaces of the recess shall be perfect.
- **6.3** It shall be free from draw-marks, pits, cracks and other surface defects.
- **6.4** It shall be passivated and polished bright.

7 CORROSION RESISTANCE TEST

- **7.1** Scrub the instrument with soap and warm water, rinse in hot water and then dip in 95 percent ethyl alcohol. Dry the instrument, immerse in copper sulphate solution at room temperature for 6 minutes and wash with fresh water or wet cotton wool.
- **7.2** The copper sulphate solution shall be made up as follows:

Copper sulphate (CuSO₄.5H₂O) 4.0 g Sulphuric acid (H₂SO₄) (Sp gr 1.84) 10.0 g Distilled water (*see* IS 1070). 90.0 ml

7.3 There shall be no red stains or spots on the instrument, but dulling of the polished surface may be permitted.

8 MARKING

Shall be marked with the manufacturer's name or recognized trade-mark.

8.1 BIS Certification Marking

The product(s) confirming to the requirements of this standard may be certified as per the conformity assessment schemes under the provisions of the *Bureau of Indian Standards Act*, 2016 and the Rules and Regulations framed thereunder, and the product(s) may be marked with the Standard Mark.

9 PACKING

The hammer shall be packed as agreed to between the purchaser and the supplier.
