- **'3.41 Re-treader** The person or body who is responsible to the Type Approval Authority (TAA) for all aspects of the type-approval under this Regulation and for ensuring the conformity of production.
- **3.42 Tyre Manufacturer** The person or body who was responsible to the TAA having

granted the original new type approval and for ensuring the conformity of production under the applicable Regulation for new tyres. "Material manufacturer/material supplier" means the person or body who provides to the retreader the retreading or repair materials.

3.43 Brand Name/Trademark — The identification of the brand or trademark as defined by the retreader and marked on the sidewall(s) of the tyre. The brand name/trademark may be the same as that of the retreader.

3.44 Trade Description/Commercial Name — An identification of a range of tyres as given by the retreader. It may coincide with the brand name/trademark.'
