Subject: The observation of "Swachhata Hi Seva 2018 (SHS)" Campaign from 15th September 2018 to 2nd October 2018.

In this connection, the following **Action Plan for implementation of Swachhta Hi Seva 2018 campaign** has been approved by Director General of the Bureau:

- (i) A "Special Cleanliness Drive" will be carried out in all offices of the Bureau from 15th September 2018 to 2nd October 2018. All employees shall participate in the cleanliness drive and clean his/her table, rack, computer and ensure dust-free surrounding during the drive. Files and records are to be weeded out as per their retention schedule.
- (ii) Action will be initiated to identify unserviceable furniture and equipment items for condemnation/ disposal before 02nd October 2018 and a compliance report will be submitted to HQs by 03rd October 2018.
- (iii) Perform Swachhta related Nukkad Nataks/ street plays, folk song and dance performances.
- (iv) The Tagline "Swachhata Hi Seva 2018 (SHS)" shall be displayed on website of the Bureau during the observance of SHS 2018 campaign.
- (v) Publicity of "Swachhata Hi Seva 2018 (SHS)" through banners/ hoardings/ back-drops of the meetings/ conferences/ programmes to be organized by the Bureau during the period from 15th September 2018 to 2nd October 2018.
- (vi) Make wall paintings in the premises of industrial estate on the theme of swachhata.
- (vii) Building compost pits during the SHS campaign 2018.

- (viii) At HQs of the Bureau, a random check of the cleanliness activities will be undertaken by DDGs in the Departments under their control. DDGRs, Heads of BOs, Heads of Labs/NITS will take a random check of the cleanliness activities in their respective offices.
- (ix) An awareness programme on "Domestic Solid Waste Management" with the Noida RWAs during the SHS campaign 2018 will be organized by BIS-NITS; Noida.
- (x) An action taken report along with photographs on the above shall be sent by all Departments at HQs/ ROs/ BOs /Labs /NITS to the Administration Department by 03rd October 2018 so that a consolidated report may be sent to DoCA.
