### **Subject: Regarding certification of Eye Protectors as per IS 5983:1980**

1. This has reference to the above.
2. Several firms who are approaching BIS for grant of licence as per IS 5983:1980, are outsourcing the manufacturing process and only undertaking assembly of components. BOs have sought issue of guidelines regarding the same.
3. This matter has been deliberated upon and it was observed that:
  - i) As per the provisions of Scheme-I of BIS (Conformity Assessment) Regulations, 2018, the licence to use Standard Mark is to be granted only to the **manufacturer**. Although outsourcing of part of the manufacturing activity can be permitted as per the Regulations, it is observed that in Eye Protectors as per IS 5983:1980 complete/important manufacturing activity has been outsourced.
  - ii) As per the request of the Department of Pharmaceuticals, BIS has made special provisions for the certification of this product i.e. considering certification without insisting for complete in-house testing facilities for the product. Thus, in the absence of testing facilities for the testing the quality of the final product, it is imperative to have in-process controls in place.
  - iii) This product is a PPE which is being used in the line of duty by frontline workers in the fight against the COVID-19 Pandemic, and as such, ensuring its quality is of paramount importance.
4. Accordingly, it has been decided that **BIS shall consider grant of licence under these special provisions, to only those firms who have complete in-house manufacturing facilities** for manufacture of eye-protectors as per IS 5983:1980.
5. This is with the approval of DDG (Certification).
