**विषय: कोविड 19 के मद्देनजर 31 दिसंबर 2020 तक ओपीडी दवा की लागत की प्रतिपूर्ति के लिए विशेष मंजूरी**

भारत सरकार, सीजीएचएस के स्वास्थ्य एवं परिवार कल्याण महानिदेशालय ने अपने परिपत्र संख्या Z 15025/12/2020/DIR/CGHS दिनांक 30 सितंबर 2020 (प्रति संलग्न) के तहत इस विषय पर पहले जारी किए गए OM दिनांक 27.03.2020 के विस्तार में यह निर्देश जारी किए हैं, कि सीजीएचएस लाभार्थियों को 31 दिसंबर 2020 तक पुराने रोगों के लिए दवाएं प्राप्त करने के लिए (सीजीएचएस चिकित्सा अधिकारियों/सीजीएचएस विशेषज्ञों/अन्य सरकारी विशेषज्ञों/पैनल के विशेषज्ञ द्वारा निर्धारित) पर्चे के आधार पर दवाएं खरीदने की अनुमति दी जाएगी। इस में यह भी स्पष्ट किया गया है कि सीजीएचएस वेलनेस सेंटर भी कार्यरत हैं और सीजीएचएस लाभार्थियों के पास बाज़ार से खरीदने के बजाय सीजीएचएस वेलनेस सेंटरों के माध्यम से दवाएं एकत्र करने का विकल्प भी है। कार्यालय ज्ञापन दिनांक 30 सितंबर 2020 की प्रति संलग्न है।

Specialists/ Specialist of empanelled hospital) till 31 December 2020 on the same conditions as per the earlier OM dated 27.03.2020. It is also clarified that the CGHS Wellness Centres are functional and CGHS beneficiaries also have the option to collect medicines through CGHS Wellness Centres as per normal practice, instead of purchasing from market.

till 31<sup>st</sup> December 2020- regarding**

In view of the Corona Virus Disease(COVID-19) , all out efforts are made by the Government to contain its impact by instituting measures at community as well as at individual level.

2. In this regard the undersigned is directed to draw attention is the OM of even number dated 27.03.2020, 29.04.2020 , 29.05.2020 and 24<sup>th</sup> August 2020 vide which an option has been provided to CGHS beneficiaries getting medicines for Chronic diseases , to purchase medicines based on the prescription held (prescribed by CGHS Medical Officers/CGHS Specialists /other Govt. Specialists/ Specialist of empanelled hospital) till 30<sup>th</sup> September 2020, irrespective of Non-Availability certificate from CGHS or otherwise. However, several representations are received in the Ministry seeking extension of the period in view of the continued 'Lock Down'.

3. The matter has been reviewed by the Ministry and it is now decided , in continuation of the earlier OM on the subject , that CGHS beneficiaries getting medicines for Chronic diseases shall be permitted to purchase medicines based on the prescription held (prescribed by CGHS Medical Officers/CGHS Specialists /other Govt. Specialists/ Specialist of empanelled hospital) till 31<sup>st</sup> December 2020 on the same conditions as per the earlier OM dated 27.03.2020. It is also clarified that the CGHS Wellness Centres are functional and CGHS beneficiaries also have the option to collect medicines through CGHS Wellness Centres as per normal practice, instead of purchasing from market.
