**Subject: Guidelines for implementation of Amendment No. 1 and 2 to IS 3768 : 1996  
“ Ventilation Ducting-Vinyl Coated, Flexible and Semi-Rigid-Specification”.**

1. Amendment No. 1 and 2 to IS 3768 : 1996 has been published. The last date for implementation of the amendments is 07 03 2018.
2. All BOs shall inform the Applicants/Licensees under their jurisdiction about implementation of the above amendments.
3. The significant changes in the amendments as listed in the Table below is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendments.

<b>Amendment No. 1</b>	
Clause 2.1	IS 7016 (Part4 & Part 5) has been substitute by IS 7016 (Part 4) : 2003/ISO 7854:1995 & IS 7016 (Part 5):2003/ISO 2411:1991
Clause 5.4	IS 7016 (Part 4):1987 has been substitute by IS 7016
Clause 5.5.5	IS 7016 (Part 5):1987 has been substitute by IS 7016 (Part 5)
Clause 6.2	BIS certification marking clause has been added
<b>Amendment No. 2 .</b>	
Clause 5.5.4	Failure in any test piece shall be deemed to have occurred when one or more cracks (not less than 2 mm long as extending through the coating to the base cloth) may be detected.

4. There are no changes in the existing STI.
5. The guidelines for implementation of the amendments is given below:

**A. For Licensees:**

- (i) All Licensees shall implement the amendment by **07 03 2018**. BOs shall ensure that no Licences are under operation as per IS 3768 : 1996 without the amendment after 07 03 2018.

- (ii) Licensees shall confirm conformance to the additional requirements through In-house/ Independent Test Reports or Test Certificates, as applicable. Verification of additional requirements and facilities, if any, may be done during the next visit.
- (iii) If the Licensee fails to complete all actions by 07 03 2018 it shall be dealt with as per OMPC.

**B. For Applicants:**

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of the amendments. However, if the Applicant is desirous of considering the amendments, a declaration from the Applicant may be obtained to that effect and the Application may be processed accordingly. An undertaking from such Applicants shall also be obtained that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed with or without consideration of the amendments. Processing of Applications without consideration of the amendments shall be permitted only upto 07 03 2018 and for such cases Applicant shall give a declaration that they will implement the amendments by 07 03 2018.
- (iii) Beyond 07 03 2018 no Licence shall be granted without consideration of the amendments.

**C. For Inclusions:**

- (i) For Inclusion of New Varieties, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of Inclusions without consideration of the amendments shall be permitted only upto the date of implementation of the amendments by the licensee or upto 07 03 2018 whichever is earlier.

6. The above guidelines come into force with immediate effect.
