**Subject: Salient Provisions -- Bureau of Indian Standards (Conformity Assessment) Amendment Regulations, 2020 - reg.**

1. Bureau of Indian Standards (Conformity Assessment) Amendment Regulations, 2020 under the provisions of BIS Act, 2016 have been notified as already circulated by Bureau Secretariat and hosted on BIS website.
2. Some of the salient provisions to take note are listed below:
  - i) Provision for renewal of licence deferred due to suspension
    - a) As per amended Regulation 8(9) - if discrepancies, which led to the suspension of the licence are not removed during the period of deferment, the licence **may be shall stand** expired after the date of its validity.
  - ii) Under Scheme - I ()
    - a) The Annexure - I (pertaining to marking fee) has been substituted.
    - b) Provision of additional concession for north-eastern areas has been provided.
  - iii) Under Scheme - III ()
    - a) The re-certification of licence shall be done in accordance with Regulation 8(3). Whereas, prior to amendment, re-certification as per Regulation 8 was mentioned.
    - b) The Annexure - II (specifying Standard Mark for different management systems) has been substituted.

- iv) New Scheme - VIII for process certification has been incorporated. This would enable BIS to undertake conformity assessment of ready-mix concrete, organic farming etc. as process certification.

3. All concerned are requested to kindly take note of these provisions.
