Subject: Fixation of Marking Fee against an IS on All India First Basis

1. This has reference to the subject mentioned above.
2. In order to avoid delay in considering grant of licence for the applications received first in All-India basis, it has been decided by the EC in its 139th meeting dated 27/07/2018 that henceforth, the tentative Marking Fee proposals for such cases, forwarded by the concerned Branch Office to Marking Fee Committee through relevant CMDs and ratified by Marking Fee Committee, are to be put up to the DG for approval.
3. This tentative marking fee shall be applicable for granting/operating licence till such time the regular Marking Fee is specified in Annexure-1 to Scheme-I of Schedule- II in Bureau of Indian Standards (Conformity Assessment) Regulations, 2018.
4. For ensuring compliance to the above an undertaking shall be obtained from the applicant in the prescribed proforma by concerned branch office such that the applicant shall abide by the tentative marking fee fixed by BIS(copy enclosed).
5. In case the marking fee, specified under Scheme-I of Schedule- II in Bureau of Indian Standards (Conformity Assessment) Regulations, 2018, is higher than the tentative marking fee, deficit amount shall be collected on or before the effective date of the specified marking fee.
6. In case the marking fee, specified under Scheme-I of Schedule- II in Bureau of Indian Standards (Conformity Assessment) Regulations, 2018, is less than the tentative marking fee, excess amount received for the remaining period may be adjusted in the marking fee to be paid at the time of renewal of licence.
7. This issues with the approval of DG and shall come into force with immediate effect.

ACCEPTANCE OF RATE OF TENTATIVE MARKING FEE

This is with reference to your letter No.....dated..... on the subject mentioned above.

We hereby agree to pay the tentative marking fee to Bureau of Indian Standards after grant of licence to use the Standard Mark on

according to IS..... at the following rates and in the manner stipulated as under till the time Marking Fee is specified under Scheme-I of Schedule- II in Bureau of Indian Standards (Conformity Assessment) Regulations, 2018:

i) Rate of marking fee:

The marking fee is payable as follows:

- (a) The minimum marking fee shall be paid in advance for the validity period of the licence.
- (b) Actual marking fee for the first year shall be calculated by multiplying the unit rate with the quantity (units) marked during the first nine months.
- (c) Actual marking fee for subsequent years shall be calculated on year-to-year basis after the first nine months.
- (d) In case actual marking fee of the operative period exceeds advance minimum marking fee paid, difference between the actual marking fee calculated on the basis of quantum of production marked and minimum marking fee shall be paid to BIS by the licensee annually during renewal of licence.
- (e) After the marking fee against the above mentioned Indian Standard is specified under Scheme-I of Schedule- II in Bureau of Indian Standards (Conformity Assessment) Regulations, 2018, variation, if any, between the values specified and the above tentative marking fee will also be accepted and increase, if any, therein shall also be borne by us from its effective date without any contestation.
- (f) In case the marking fee is less than tentative marking fee no request for refund for the elapsed period will be raised by us.
